

Avante Body Contouring Contest Rules

Void where prohibited. Contest begins on April 1, 2017 at 12:00 AM and ends on June 30, 2017 at 11:59 PM. All times in this contest refer to Central Time. By entering the drawing, entrants agree to waive any right to claim any ambiguity or error in these Official Rules, or the drawing itself, and agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are binding and final.
